#### Pastor Report Jared Rakness

Grace and peace to you from God the Father, and our Lord Jesus Christ. Amen.

A year or so into my first call as a pastor, the local community health person came to one of our ministerial meetings. She wanted to talk to us about what could happen if there was another pandemic similar to the 1918 Spanish Flu. She told us that the churches and all community gatherings would be stopped for up to 2 months, but that we as clergy would be busy ministering to the sick and dying. She advised us to have 2 months of expenses in the bank and have a plan for how we would do ministry during such a time. At that time two months seemed crazy, but after 2020's pandemic, I would gladly take just 2 months. Even though it has been much longer than 2 months, I am eternally grateful that the number of deaths for our community of faith is very, very low.

Of all the plans we had as a congregation for 2020, we didn't accomplish very many, if any of them. But here is what we did accomplish:

- The church council and leaders were able to make difficult decisions related to in-person ministry. Including closing the building and then slowly re-opening.
- Thanks to the foresight of our leaders over the past few years, we had the necessary technology in place to move worship to an online only service very easily. And thanks to our audio/video volunteers we were able to make sure every Sunday was on-air.
- Our worship leaders were able to think through and make the necessary changes to make online only worship services the best possible.
- Throughout the year our giving remained strong as members continued to mail in their offerings or utilized the online giving platform.
- Sunday school moved completely online and was able to produce a wonderful Christmas program thanks to all of the parents who sent in videos.
- We were able to fill our student pastor position, and welcomed Adam Guthmiller to our congregation.
- We did our best as a congregation to stay connected to our neighbors through phone calls, cards, and letters.

When I look back on 2020, even though we didn't get many things that we had planned completed. The year threw us an even greater number of things to do, and thanks to all of you, our leadership, and the staff we were able to meet each of these challenges.

As for this new year, it's hard to know when things will return to normal, so we will continue to do what we can given the situation making sure we fulfill our mission of "Sharing Christ's Love With All".

#### Student Pastor Report Adam Guthmiller

Grace and peace to you from God the Father, and our Lord and Savior Jesus Christ. Amen!

It has been a privilege to be welcomed as your student pastor early this fall, and a privilege to join you in the work of the gospel. The uncertainty and spread of the COVID pandemic has forced the church to look at *how* one does ministry. How do you worship? When is it appropriate to open up the church building? What is essential to Christ's ministry and what is inessential? These are the sorts of questions you have dealt with since early 2020 as COVID began, and now as serving you, I have had to wrestle with as well. There is -- as I joke with some of my classmates -- no "Pandemic" class in seminary one can fall back on! But even in the midst of this pandemic, the ministry of the gospel of Christ at West Nidaros has thankfully pressed on.

As a seminarian and candidate for ordination, I have sought to receive each day here as a gift -- an occasion for the Holy Spirit to *teach* what the call to ministry entails. This *teaching* happens often through the act of *doing*, and so this understanding has framed how I approach the work and experiences here at West Nidaros. All of these things are how God continues to *teach* how to *minister*. A couple of the activities that have been formative for this include: worship planning with Pr. Jared and Kristi, serving as an assistant during worship, preaching, helping plan and teach confirmation classes, starting a weekly Bible study on 1 Thessalonians, and the many pastoral conversations which inevitably come with parish ministry. These have been joys for me to do with you.

As the pandemic hopefully cedes, I am equally hopeful that normal church activities are slowly brought back. I am excited to someday hear the noise of children running through the halls after worship (Pr. Jared tells me it can be chaotic), and I am excited for all the new ministry opportunities the new year will bring for us at West Nidaros.

As we close this year I want to thank you for your graciousness and kindness in allowing me to join you in your mission of *Sharing Christ's Love With All* as your student pastor. I look forward to continuing this mission with you as we enter this new year. *Hearing, speaking,* and *holding dear* the life-giving words of promise that God has given us through His beloved Son, Jesus Christ: "peace I leave with you; my peace I give to you (John. 14: 27).

#### Director of Faith Formation Report Jessi Rakness

- The Board of Education started off 2020 by planning two summer movie nights, setting VBS dates, setting the date for the Christmas program and hot cocoa bar, and then it all changed.
- Christian Education went over notes the 2019 Christmas program the hot cocoa bar was well received and we'll have it again next year; the new stage and microphones worked very well; we would like to add Confirmation and high school students to the program; we will work with the Properties committee to have more chairs set up and available for people.
- Each grade (except preschool) has a milestone in which they lead a part of worship. In January, the 1<sup>st</sup> grade class lead the congregation in The Lord's Prayer. In February, the 5<sup>th</sup> grade class will lead the Apostle's Creed. Our milestones were then put on hold until we come back for in person Sunday school.
- March 8<sup>th</sup> was our last day of in person Sunday school. THANK YOU to all of our amazing Sunday school teachers!
- The Lent devotion I purchased for families became an email sent to members who wanted it.
- I record the children's message every week for Sunday's worship service.
- Planning GIFT Sundays GIFT stands for Growing In Faith Together. GIFT Sundays are for everyone of all ages in the congregation to come and learn together. On GIFT Sundays, instead of parents dropping off their student(s), they join them. There is not regular Sunday school classes on GIFT Sundays. GIFT Sundays have been attended by about 60 people each Sunday. In 2020, we were able to have GIFT Sundays on January 12<sup>th</sup>, February 9<sup>th</sup>, and March 8<sup>th</sup>.
- After Easter, I lead Sunday school on Zoom until the beginning of May.
- I attended the Tri Valley graduation parade in May.
- Planned Vacation Bible School with the Board of Education. This is the second summer we have created our own lessons, crafts, snack, and game based on our own theme, "God's Love is out of this World." However, I purchased supplies and put them in a bag along with their t-shirt for families to pick up at church and bring home. This year we called it "VBS in your Backyard!"
- Ordered face masks and changed the Blessing of the Backpacks to the Blessing of the Face Masks. Students, teachers, and school workers could pick up a free face mask at church along with a prayer by age group for the school year. I mailed a postcard to families about the Blessing of the Face Masks with a hand written note.
- Sunday school began in September on Instructure Canvas online. I record a lesson each week for preschool-2<sup>nd</sup> grade, 3<sup>rd</sup>-6<sup>th</sup> grade, and the children's message. We continue to use the Whirl Lectionary curriculum which follows the scripture readings from worship each week. I ordered the main lesson book, one packet for each grade, and the DVD videos to help me plan the lessons. I like how it ties together the church season, special holidays, and bible stories with living our faith.
- 3<sup>rd</sup> grade Bible Sunday October 18<sup>th</sup> we had a separate service for our 3<sup>rd</sup> grade students and their parents. I pre-recorded their lesson about the bible and how to use it. I assisted with handing them out during worship. THANK YOU to WELCA for the awesome "Adventure Bible" for our 3<sup>rd</sup> grade students!
- The Rite of Confirmation for our 9<sup>th</sup> grade students was a separate service with Pastor Jared, Elise, and me. THANK YOU to all those who helped make Confirmation a meaningful experience for our students and their families.
- Trunk or Treat was an outdoor event in the church parking lot on October 31<sup>st</sup>. THANK YOU to the cars who handed out candy and to everyone who participated! I also handed out crafts, toys, glow sticks, and a November devotional book on being thankful.
- Virtual Christmas Program I emailed families inviting students to read a scripture verse or share Christmas music. Parents took a video of their student(s) and emailed it to Elise. I put together scripture verses that foretold the Christmas story and are part of the Christmas story. THANK YOU to parents for their work with this, to Elise for putting together an amazing video, and to the students who did a wonderful job! The feedback has been very positive. Also, students were more comfortable recording a video rather than getting up in front of the congregation. We will keep this in mind as we plan future programs.

- Communicate with parents and students on Facebook, through emails, phone calls, and texting. Send weekly emails to Sunday school teachers (when we had in person Sunday school)

- Give visiting families "The Jesus Storybook Bible"
- Write letters of recommendation for scholarships and jobs
- Purchase books and resources to stay current in Faith Formation happenings and changes.

#### Director of Youth & Family Ministry/Office Administrator Report Elise Hasche

#### **Youth Ministry**

- Partnered with Jessi to lead iFaith (4-6 grade ministry), once or twice a month at the beginning of the year until everything shut down. We have put iFaith on hold for the 2020-21 school year.
- Took on the challenge of teaching confirmation online this year like many other churches. Started using the platform "Canvas" to assist in sending out lessons and worksheets. Has been a learning and growing experience for all! In November, we started letting students decide if they wanted to join in person for lessons. We vary from 1-12 students in person with the rest joining us via Zoom.
- 16 9<sup>th</sup> grade students were confirmation on Reformation Sunday during a separate service. Personalized face masks were made by "Quilted in Prayer" for each student.
- High School Ministry also looked different this year. We started off the school year meeting outside, having bonfires and playing games. We now meet inside but stay primarily in the Family Life Center so we can social distance better.
- I built a Gaga Pit and benches for ministry use! We now have a proper fire pit area in the south parking lot that can be used.
- The summer trip to Perry County, Kentucky with Appalachia Service Project (ASP) was cancelled due to the pandemic. We chose to donate half of the money we had already paid in to help support the ministry of ASP.
- We are preparing to travel back to Rainbow Trail Lutheran Camp in Hillside, CO this summer for another adventure on the mountain! We have 22 students and 4 adults going.
- Confirmation camp also got cancelled due to the pandemic. We are hoping to send both classes next summer so everyone can experience the awesomeness of camp!
- Put together the Sunday school Virtual Christmas program. It was a labor of love!
- Staying connected with students and parents through email, texting, Facebook, and Instagram.

#### Office Administrator

- Create and update worship and announcement slideshow using the program Proclaim.
- Create The Reporter Newsletter each month to keep the congregation informed. Thankful for the ladies who help assemble it every month!
- Launched a new website that is much more user friendly and easier to update. It is updated weekly.

- Create weekly publications include worship bulletins, announcements, and the WN Weekly email.
- Tried to stay on top of all the baptisms we had this year! Lots of documents filled out!
- Continue to keep our Facebook page up to date with announcements, pictures, events, and other informative content.
- Created mailings and posters for children, youth & family, stewardship, WELCA, and anyone else who needs one. Created a special Easter EDDM (Every Door Direct Mail) Postcard for residents of Renner & Crooks just in time for COVID to shut everything down!
- Video editing is my new project! Did a handful of videos this year including stewardship and the SS Virtual Christmas Program.

#### **Other Ministry**

- Help lead worship through music most Sundays since the start of the pandemic schedule.
- Help with funerals as needed (sound, music, etc).

#### Director of Worship & Music Report Kristi Stelter

"Make a joyful noise to the Lord, all the earth. Worship the Lord with gladness." Psalm 100:1

Worship at West Nidaros has most definitely taken some "twists and turns" during 2020! Fortunately, the church had already taken the steps necessary, with the upgrades to our sound and visual equipment, to seamlessly transition to virtual worship when that need arrived in March. Funny we mention having that "2020" vision, and West Nidaros really DID have the vision of what we would need to continue our mission of reaching people when Covid-19 disrupted our daily lives and routines. I, along with the rest of the WNLC staff, can't express enough appreciation to the Audio/Visual team for taking on the responsibility of bringing worship into our homes every week and all that was involved with that task. I also want to express my unending appreciation to the many musicians who were able to lead music on a weekly basis to allow for a better worship experience, especially for those worshipping from home.

Throughout the past year, we had to adjust our schedule of worship styles as we moved to only one service per week. We aimed to provide a variety of worship styles and addition to the traditional worship from the ELW, we incorporated the use of contemporary or blended styles of worship. To break this down, the "Texas Kyrie" liturgy was used for nine services; six services were contemporary worship, with four of those being led by the Call; six services used "Light into the World" liturgy and four services with the "Now the Feast and Celebration" liturgy. This past year has demanded an elevated commitment from all areas to continue our mission of "Sharing Christ's Love with All", and I am so very blessed to be a part of this ministry!

The role and primary responsibilities of Director of Worship and Music for 2020 have included:

#### **Worship Planning and Implementation:**

- Collaboration with Pr. Jared and other staff to plan worship schedule
- Selecting hymns for traditional worship services
- Scheduling of organists

- Providing and assisting with worship accompaniment when needed
- Arranging for special music during worship services
- Music selection and preparation for blended/contemporary worship
- Providing keyboard accompaniment for blended/contemporary worship

#### REPLICA CHURCH ANNUAL REPORT

The Nidaros Replica Church is a one-third scale replica of the original Nidaros church handcrafted by the late Art Moe, a member of West Nidaros for over 90 years. The structure was moved from Art's farm to the church grounds in 1993. In 1995 the \$10,000 which Art had designated for the maintenance was placed in an endowment. Later the estate of Leo & Hazel Reppert provided a gift of over \$100,000 to be used for upkeep and maintenance of the replica church. The Reppert gift is invested in the West Nidaros Horizon Fund. The Replica Committee serves to preserve the heritage represented by the mission and ministry of the Nidaros congregations, forerunners of West Nidaros, but providing for the care and preservation of the replica.

This year with the pandemic the church was locked most of the year. True-Green Lawn Service sprayed and fertilized the lawn. The summer mowing and trimming was done by the same company that mows the church lawn. Cheryl Anderson and Kathy Neeb again do an excellent job keeping the replica cleaned and polished for viewing when needed. The water was turned off to prevent freezing pipes.

No summer weddings were performed by Pastor Jared Rakness in the Replica Church. The Replica Church may be used for baptisms, weddings, special services and tour groups. Please contact the church office to make such arrangements.

Robert Oyen continues as chairperson and Gary Brendtro as treasurer.

The log cabin did not experience as many visitors this past year because of the COVID epidemic. However, several maintenance projects including a major renovation of the exterior were accomplished.

The Hanson -Oyen cabin is not financially supported by the WN congregation budget. All funding for maintenance and purchases are dependent upon local gifts from our membership, friends, families and visitors. The cabin is associated with the Minnehaha County Historical Society.

Donated cabin artifacts (gifted or loaned) that are size and time period appropriate are always welcome. Artifacts, financial support and volunteer support are all important for their value in this on-going living history project.

This past summer it was determined that the deterioration of many of the original side-wall timber logs were in need of replacement. The entire exterior (except for the covered-exposed northwest corner), has been sided over with cypress wood siding. We give special thanks to Mike Geppert of Crooks for directing and completing this project. We also thank Nick Swier for making and providing the clear polypropylene plastic northwest corner covering. This permits visitors to see what the original notched timber beams looked like. Volunteer help is always appreciated for upkeep and maintenance during the summer months. The cabin is open for viewing from May through September and at other times by appointment. Dear Siblings in Christ of the South Dakota Synod,

Grace and peace to you in the name of the Father, and of the Son, and of the Holy Spirit!

"But we had hoped" – is probably the most used phrase of 2020. However, this is also the phrase of the two disciples walking from Jerusalem to Emmaus after Christ's death and resurrection. While on the road wrestling with things

that they cannot understand, Jesus joins them on the road, sharing with them how all of these things rested in God all along. It is not until the breaking of the bread that the holy heartburn the two disciples felt all along propels them to run back to their friends to share that Christ truly is alive and not dead, and that therefore his followers need to live into the promise that they too are alive and that death has lost its power.

I cannot help but come to understand that this story is our story. It has always been our story, but 2020 has brought this story alive for me in new and profound ways. We too have found ourselves saying countless times this year, "but we had hoped." We too wrestled with the hard questions about what to make of the events of this past year as they unfolded in our life. We have wished many times to go "back to normal." As I heard from people, I invited them to expound on what going back to normal means to them. Creating this space allowed for a deeper reflection on who we are as people of God in South Dakota. Jesus accompanied the disciples on the road and shared scripture with them to open their eyes to God's continued provision and presence in the world. Even in the midst of these life-altering and events of Christ's death and resurrection God is alive and at work. My staff and I have accompanied your community of faith during this life-altering pandemic assuring you that God's Holy Spirit is inspiring and sustaining.

Early on, we hosted weekly Zoom meetings for rostered and lay leaders. We continue these meetings on a monthly basis. Task forces were created to provide resources and training for congregations to continue ministry, such as "Canvas" an online resource platform and network for everything educational. Two worship documents and guidance were created: "Extending the Table, Expanding Participation" and "Come Let us Worship in a New Way." I can say that the pandemic and the challenges of living into a new way of being church has created some heartburn. Many may not call it a holy heartburn, but remember neither did the disciples until they sat at the table with Jesus and ate. Only when bread was broken, and wine was poured, did they remember the promises that God's got them and that they have nothing to fear. I pray that you too will come to recognize and interpret your heartburn as holy heartburn that empowers you to be church in a new and different way for the sake of the Gospel.

Thank you for your continued support and partnership. Now, as we move forward, let's commit

ourselves to journey together in Christ, and in Christ alone.

The 2021 mission plan for the synod was discussed and proposed by the Synod Council in the absence of the Synod Assembly being able to convene and pass a mission plan during 2021. The mission plan is reflective of the Synod Council's hopes for how we, as the church, will be able to support and engage in ministry together, while recognizing the unusual uncertainty which began in 2020 and may continue in 2021. Accordingly, the Synod Council proposed a flat budget based upon the congregational statements of intended mission support for the 2020 mission plan year. No significant changes from the 2020 mission plan were proposed other than prudently planning to reduce meeting and leadership realted expenses in order to propose a balanced 2021 mission plan.

In 2019, we listened to you and learned from you in order for us to care for you as the body of Christ in South Dakota. As we live into the realities of the COVID-19 pandemic, many things that were said in 2019 are ever more present.

- Knowing things were already tough at the start of 2020, we provided opportunities for Mental Health First Aid and Psychological First Aid in response to the farm stress crisis.
- 18 leaders were trained as Peer Mentor Facilitators, creating four Peer Mentor Groups for our first call leaders to mutually support one another.
- The synod's **Coaching Network** expanded, with a new cohort of coaches and further training options for existing coaches.
- Congregations and the synod were able to begin or expand digital worship, allowing us to proclaim the Gospel in a new way, and often reach new people.
- The synod is investing resources into Canvas, a digital teaching platform to help Christian Education be reformed in the midst of the pandemic.
- We started the **Justice Table**, a group of people committed to confronting racism in South Dakota, which will focus on Education, Advocacy, and Community Organizing.
- Journeying Together in Christ, the synod's strategic vision plan, was created and rolled out after conversations with people across the synod.
- **A Worship Task Force** was created, which published guidelines and suggestions for worship during the pandemic.
- Despite cancelling Synod Assembly, we gathered digitally this Fall via the **Synod Day** event, and still celebrated our work together through speakers and worship.
- **A Faith Formation** task force was created to navigate options for congregations in different situations in the pandemic.
- We received numerous grants from our Lutheran partner organizations, including from the ELCA Domestic Mission Unit, Lutheran Disaster Response, ELCA COVID Relief Fund, as well as numerous outside organizations.
- The **Storyteller Network** was launched as a group of people committed to telling ministry stories of what the Holy Spirit is up to in South Dakota through our ministries.

# LUTHERANS OUTDOORS IN SOUTH DAKOTA 2020 CONGREGATIONAL REPORT

### Lutherans Outdoors in South Dakota welcomes all to explore and experience Christ's love in community and creation.

The year 2020 may not have allowed Lutherans Outdoors to share four beautiful ministry sites with you, but it has not stopped Lutherans Outdoors from continuing its mission. Lutherans Outdoors is still a vibrant, meaningful ministry that will continue to provide life-giving and faith-growing experiences for people of all ages for years to come.

#### **PROGRAM**

On March 13, 2020, the Lutherans Outdoors' Board of Directors made a decision to stop all programming at our camp sites for a 10-week period. On April 7, 2020, the Board of Directors made the decision to cancel the summer program at Outlaw Ranch, Joy Ranch, NeSoDak, and Klein Ranch. This was the right decision, yet very difficult.

The empty camps continued in this way for the rest of the year, except for some horse riding programs at Joy Ranch and some family rentals at Outlaw and NeSoDak. It will continue to be quiet during the first months of 2021.

Lutherans Outdoors found several ways to keep the relational ministry happening last summer through successful special event fundraisers. Klein Ranch had many supporters participate in the Adopt-A-Horse program. Joy Ranch held special drive-thru Chef Nights. NeSoDak had a fun Road Runner 5K Run/Walk. Outlaw Ranch offered a Thursday night Concert Series featuring Family Camp musicians from past years with a special Christmas Concert in December.

We look with optimism and excitement to Summer 2021! Lutherans Outdoors is moving forward in providing summer camp programs at a 60% capacity for the summer of 2021. We are hopeful that retreats and gatherings can begin again this fall. It will be wonderful to hear the laughter and music and life that has been missing for too long.

We hope that your congregation can feel safe at camp and allow Lutherans Outdoors to provide an important and much needed faith-growing experience called Bible Camp for members of all ages. We will see you at camp!

#### FINANCIAL NEED

During the course of our need to cancel summer camp and not host retreat groups, Lutherans Outdoors lost approximately 1.7 million dollars of anticipated income. The loss of revenue will continue into 2021 with the hope that revenue streams can begin again with summer programs---but they are not guaranteed.



Thus, there has been a great need for financial help from our ministry donors. And many, many of them did indeed make wonderful financial contributions to help fill the revenue need. Lutherans Outdoors also was able to receive a Federal PPP loan.

But the financial need is still great and we will be making a large financial ask during 2021 through our **Keep The Campfires Burning Appeal.** Your congregation will be receiving and sharing information on how you can make a vital decision to help Lutherans Outdoors continue to be a strong ministry through a generous donation.

Greetings from your camp - Shetek Lutheran Ministries!

What a year! We welcomed Amanda Randall as our new Program Director on Feb. 23 and three weeks later everything was turned upside down. Amanda has done a great job adapting and rising to the challenge of camp programming during a pandemic. Unfortunately, we were not able to do all our programs in 2020.

During these times, we have had to be very creative to carry on our mission. Obviously, a big part of our mission is our summer programs for youth and families. But another part of our mission is the faith formation and leadership development of the young adults who serve on our summer ministry team. Many of them go on to serve the church in rostered leadership positions and/or lay leadership. We committed to hiring our summer staff of 20 this past season, not knowing if we'd be able to have overnight camp or not. We want to support their development along with their summer employment. Several scenarios were being planned.

In the middle of June, the MN Department of Health came out with guidelines for overnight camp and we put our plans into action. Most camps cancelled all their summer onsite programs but we felt if there was a way to offer programs as safely as possible, we wanted to try, for the sake of the campers who would have an opportunity to attend. Safety is a high priority and we followed the CDC guidelines and MN Dept. of Health recommendations and worked with our local public health officials. Our programs were adapted and we ended up with 5 weeks of programming from July 5 to August 7 with 265 participants.

Even though this was a difficult summer with a lot of extra work to make it happen, it was well worth it. Our summer ministry team learned to adapt, were very creative and learned resiliency! Our campers were very thankful to have an opportunity to come to camp even though it was different from previous years. We are very thankful also that we had no incidents of COVID-19.

Our "Building on the Foundation" capital campaign was on hold for most of the year. We started the congregational phase in Feb. but then had to suspend it in March. The Board voted at the end of September to begin some of the infrastructure work, so we have started on the building to house our new water treatment equipment. Our plan is to get the equipment in this winter and switch the system over next spring. The architect is almost finished with the plans for the Adult/Youth Lodge and we hope to begin in the spring of 2021 on the first new building! We are at \$1,100,000 in gifts and pledges towards our goal of \$1,500,000.

Some improvements in 2020 – painted the ceiling in the kitchen and the ceiling and back hallway in Dakota and painted the apartment building and cabin #5. We also had to repair a sewer line by the dining hall. Thanks to wonderful volunteers we have a new deck and stairs on the back of the chapel and we removed several dead trees and stumps. Many other improvements also happened.

I am thankful for the year round staff who have struggled this year with fewer campers, retreats and programs. They have been positive and supportive of each other through everything. I hope we can return to something more normal soon.

I'm also thankful for the Paycheck Protection Program loan we received along with some grants. Those have been very helpful. Compared to 2019, we will be about \$180,000 lower in program income and about \$60,000 lower in retreat/rental income. However, in the face of all the uncertainty, our donors and congregations have responded with incredible generosity and I can't say "THANK YOU" enough for your support and prayers!!

LSS helps to transform the lives of people of all ages, faiths, races and economic status with professional, confidential and affordable services. With vital services offered statewide, LSS touched the lives of those we serve 38,099 times last year. LSS is where life stories take shape. We strive to care for, support and strengthen those in need, bringing clarity, stability, family and support to people of all ages, families of all kinds and communities of all sizes.

LSS has assisted with 4, 184 ADOPTIONS SINCE 1920. We are ready for a second century of service.

The COVID-19 pandemic created many challenges. LSS has reacted quickly, safely and compassionately to offer many of our services using telehealth technology. It is a good alternative for individuals and families experiencing overwhelming stress and anxiety associated with separation and isolation.

Clients receiving outpatient counseling experienced a 23% reduction in symptoms from the first session to the fourth session.

LSS continues to improve its capacity to deliver trauma-informed care. 91% of youth in Psychiatric Residential Treatment and 83% of youth in Foster Care showed a reduction in trauma symptoms upon discharge.

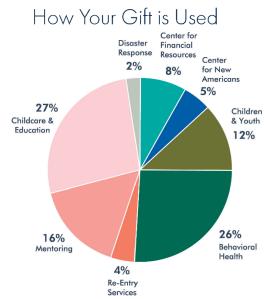
**85%** of clients who received financial counseling reported reduced stress after their session. **88%** of clients participating in a debt management plan successfully completed their payments.

100% of the residents of the New Alternatives Intensive Independent Living Services improved their independent living skills and improved their overall wellness and health.

Youth who participate in the Arise Shelter Care are successful. **90%** of youth are discharged to safe and stable housing.

For 100 years, LSS has not just been about looking at one person and trying to help them with their situation, but coming from a bigger, more holistic picture. It's not just one person's life today, it's about what do we do to make things better into the future, for other people.
